Base Coat

- (i) Fix all ingredients except the aluminium powder. Blend well.
- (ii) Add in aluminium powder paste. Mix well.

Dyed Coat

(i) Mix all ingredients & blend well.

(d) Applications Guideline

- (i) Dilute with xylene to spray viscosity. 15-30 sec #4 Ford Cup.
- (ii) Apply the base coat. Dry well before applying the glittering coat.
